River Electric Cooperative (SREC) Wildfire Plan is in the works. The final Montana Code that was put into law has public notice and review periods incorporated. In this addition of the *Ripples* a public notice is included. Please mark the date on your calendars if you have a desire to express concerns or offer input into the SREC plan.

The Wildfire Mitigation Plan is available for review in two ways. Members of the cooperative can request a copy of the 12-page plan be sent to them. Either call or write to make your request. The office personnel



will ask you to identify your account number to verify your membership status. A second option

is to come into the office and read the plan while enjoying a cup of coffee or a cold drink. We always invite our members to come and see us!

The finalization schedule will be a 45-day review period, a public meeting, final approval by the board of trustees and then implementation prior to Dec. 31. We look forward to your participation.
