# YOUTH TOUR 2024

**T**HE 2024 National Rural Electric Cooperative Association (NRECA) Youth Tour to Washington, D.C., was held June 15-21. This year, there were 40 states represented and 1,600 kids. Sun River Electric Cooperative (SREC) sent Cole Waldusky from Conrad and Kristen Boumans from Valier. They toured with other kids from Montana co-ops; this year there were 32 kids from 20 cooperatives. During the seven-day trip they learned about cooperatives, met with legislators and checked out the many monuments and historic sites in Washington, D.C., as well as made many memories and new friends.

Every year a student from each state is selected to represent their state as the Youth Leadership Council (YLC) delegate. Cole was selected to be the Montana YLC. He will be working with SREC to do a community service project, and will do a presentation for the Sun River Electric Board and for the 2025 Annual Meeting. He will also attend the NRECA Annual Meeting and do leadership training with other students from across the United States. Congratulations Cole!
