2020 Rate Details

In last month's *Ripples*, I promised **■** details on rate changes starting January 1, 2020.

In most cases, the demand charge has increased, but with a corresponding decrease in base charges and energy charges. Some examples:

The Residential Rate demand charge increases one dollar, from \$5/kilowatt to \$6/kilowatt, but the monthly base rate decreases one dollar, from \$31/ month to \$30/month. More importantly, the energy charge decreases 10 percent, from 6.216 cents/kilowatt hour to 5.596 cents/kilowatt hour.

The Irrigation Rate is a little more complicated since there are actually three different rates. In all three cases, the energy charge stayed the same, the demand charge went from \$1/kilowatt to \$3/kilowatt, and the base charge decreased. The Historical and Budget base rates (three-phase) decreased from \$408/season to \$312/season. Single-phase decreased from \$336/ season to \$264/season. The Electronic base rate decreased from \$34/month to \$26/month, and single phase decreased from \$28 to \$22/month.

Small Commercial (GS-1) will have the same base charge, the demand charge will go from \$3/kilowatt to \$4/ kilowatt, and the energy charge will decrease from 7.961 cents/kilowatt hour to 7.6 cents/kilowatt hour.

Large Commercial (GS-2) will have the same base and demand rates in 2020, but the energy charge increases 1/10 of a cent/KWH from 6.268 cents/ KWH to 6.368 cents/KWH.

All of the rate changes for next year, in total, amount to an increase overall of about 1.56 percent.

A higher demand charge and a lower energy charge means your monthly bill is more dependent on how and when you use energy and less on how much energy you use.
